How to pack your Christmas box

- 1 Find an old shoebox. Any size will do!
- 2 Separately wrap the bottom of the box and the lid in bright festive paper.
- 3 Decide who you'd like the box to go to - adult or child, man or woman. Fill in the check boxes on section 1 to say who your box is for, and stick this to your box lid.
- 4 Have fun selecting and buying as many items as you like for your intended person. Put each item unwrapped into your box. [Please note that each box has to be checked before it leaves the UK]. If you are stuck for ideas check out our suggestions.
- 5 Fill in your details on section 2 of the attached form.

- 6 Attach your donation to the form in Section 2 and put completed form inside your box **£2 will cover distribution costs of your Christmas boxes.**
- 7 If you can, tick the Gift Aid declaration - this allows The Trussell Trust to claim back tax on your donation meaning we get an extra 28% at no cost to you.
- 8 Deliver your box to The Trussell Trust by 25th November (address overleaf)
